

Shelburne Contest Rules – Deck the Door

1. **Eligibility:** The Shelburne Deck the Door Contest is open to residents of the Town of Shelburne Ontario, Canada who post and share a picture on the Town of Shelburne’s social media pages (Facebook, Instagram, and Twitter). Entrants must be 13 years of age or older as of their date of entry in this promotion to qualify. This contest is subject to Federal and Provincial laws and regulations.
2. Town of Shelburne employees, its subsidiaries, affiliates, suppliers, partners, directors and councilors (collectively the “Employees”), as well as members of an Employees' immediate family and/or those living in the same household of Employees, are ineligible to participate in the Shelburne Deck the Door Contest.
3. **Sponsorship:** The sponsor is the Town of Shelburne, located at 203 Main Street East Shelburne Ontario L9V3K7. Sponsor will conduct the Contest as described in these
4. **Official Rules:**

Agreement to Rules: By entering this Contest, the Entrant (“You”) agrees to:

- a. Abide by the Sponsor's Official Rules and decisions, which are fully and unconditionally binding in all respects.

 - c. By entering this Contest, the You represents and warrants that You are eligible to participate based on eligibility requirements explained in the Official Rules.
 - d. You also agree to accept the decisions of the Sponsor as final and binding as it relates to the content of this Shelburne Deck the Door Contest.
5. **Shelburne Deck the Door Contest Entry Period:**
 - a. This promotion begins on November 18, 2020 and ends on December 10, 2020 at 12 noon. To be eligible for the Contest, entries must be received within the specified Entry Period.
 - b. **How to Enter:** Eligible entrants can enter The Shelburne Deck the Door Contest by submitting a picture to a minimum of one of the Town of Shelburne Social media sites (website, Facebook, Instagram, and Twitter). As a participant, your entry must fully meet all Contest requirements, as specified in the Official Rules, to be eligible to win the prize. Incomplete entries or those that do not adhere to the Official Rules or specifications will be disqualified at the Sponsor's sole discretion.

- c. Fraudulent methods of entry or circumvention of the rules may result in the Sponsor invalidating your entries and removing them from the Contest at the Sponsor's sole discretion.
6. Prizes: The Winner of the Shelburne's Deck the Door Contest will receive one (1) \$100 gift certificate from a Local registered business of their (your) choice. There shall be no cash or other prize substitution permitted except at the Sponsor's discretion. The prize is non-transferable. The Winner, upon acceptance of the prize, is solely responsible for all expenses related to the prize, including without limitation all local, Federal, or Provincial taxes.
 - a. The Winner shall not transfer assignment of the prize to others nor shall the Winner request the cash equivalent or prize substitution. By accepting the prize, the selected Winner grants permission for the Sponsor to use the Winner's likeness, entry, and name for purposes of advertising, without further compensation unless prohibited by law.
 - b. The Business must be registered with the Town of Shelburne. The Town requires all businesses located within Town limits to be registered with the Corporation of the Town of Shelburne
7. Odds: The total number of eligible entries received determines the odds of winning.
8. Selection and Notification of Winner: The Winner will be selected by community vote - Likes on Social, and a panel of judges, under the supervision of the Sponsor.
 - a. The Sponsor will notify the Winner by contacting them through social media or by email within 5 business days following the Winner selection.
 - b. The Sponsor is not responsible for nor shall have no liability for Winner's failure to receive notices due to security settings that may cause notifications to be marked as spam or junk. Nor shall the Sponsor be liable for the Winner's provision of incorrect or otherwise non-functioning contact information.
 - c. If the Winner 1) fails to claim the prize within 3 days from the time the award notification was sent the prize may be forfeited and an alternate Winner may be selected.
