

## **MAINTENANCE ELECTRICIAN**

### **Job Summary**

The Electrician will work as part of a team to install, test, troubleshoot and repair electrical wiring, fixtures, control devices and related equipment in a manufacturing environment. This individual will have the ability to read and interpret drawings, blueprints, schematics, and specifications in order to provide troubleshooting and repair services. ### **Summary of Essential Job Functions**

- Timely and organized response to equipment related problems that impact production requirements

- Maintain accurate and up to date maintenance records and work orders

- Test electrical systems and continuity of circuits in electrical wiring, equipment, and fixtures
- Work on other electrical projects as required and coordinate with Electrical Contractors
- Ensure all work performed adheres to all relevant company, provincial and federal safety regulations, codes, and specifications
