BY-LAW NUMBER 25 -2015

**BEING A BY-LAW TO AMEND BY-LAW 15-1998, BY-LAW 20-2004 AS AMENDED BY
BY-LAW 14-2012 WHICH PROVIDES FOR ESTABLISHING TARIFF OF FEES
FOR FIRE DEPARTMENT SERVICES**

WHEREAS, the Municipal Act, 2001, S.O. 2001, provides that the Council may by By-Law impose fees for services and activities provided or done by or on behalf of the Corporation of the Town of Shelburne;

AND WHEREAS, it is expedient to impose fees for certain services provided by Fire Departments servicing the Town of Shelburne;

NOW THEREFORE THE MUNICIPAL COUNCIL OF THE CORPORATION
OF THE TOWN OF SHELBURNE ENACTS AS FOLLOWS:

1. Schedule B to By-Law Number 14-2012, is repealed and replaced with the new Schedule B attached hereto.

HOURLY RATE FOR FIRE VEHICLE RESPONSE

Fire Vehicle response \$665.00 per hour and every additional half hour \$332.50.

Services not required (flat fee) \$665.00

FALSE ALARM RESPONSE FEES

ITEM	<u>COLUMN 1</u> Frequency of False Alarms	ITEM	<u>COLUMN 2</u> False Alarm Fee
1.	Two or more false fire alarms to the same building in any thirty day period	1.	\$300.00 flat fee for the second false fire alarm and for any subsequent false fire alarm in that thirty day period
2.	Four or more false fire alarms to the same building in any twelve month period	2.	\$300.00 flat fee for the fourth false fire alarm and subsequent false fire alarm in that twelve month period
